- 2. Scope of Work attachment no. 1 to the tender inquiry.
- 3. Contract Site the exploration area is covered by the Contract with the International Seabed Authority is located in the northern part of the Mid-Atlantic Ridge, between the area covered by the Portuguese Continental Shelf Extension Request and the French (IFREMER) exploration area.
- 4. Contract completion date: no later than December 15, 2022, including:
 - 1) execution of the surveys between May 15 and September 15, 2022,
 - 2) execution and submission of the final data interpretation to the Ordering Party no later than 3 months after completion of the surveys.

5. Requirements for Tenderers:

1) Knowledge and Experience:

The Tenderer will meet the condition if can demonstrates that within the last five (5) years before the deadline for submission of tenders, and if the period of activity is shorter, in this period - has performed a minimum of one (1) service consisting of exploration of deep-sea areas, i.e. measurements of the bottom surface and acoustic and physico-chemical properties of the water column carried out from the board of vessels using remote measurement methods, including in particular the acquisition, processing and interpretation of data: bathymetric data collected using a high-resolution multibeam echo sounder (MBES), acoustic backscatter, acoustic and physico-chemical data of the water column, magnetic anomalies.

To confirm fulfilment of this condition the Ordering Party requires submission of a list of services (attachment No. 2 to the tender inquiry) including the scope of performed surveys, purpose, place and entity for which the service was performed, together with evidence stating whether the service was performed properly, whereas the evidence referred to are references or other documents issued by the entity for which the service was performed, and if for objective reasons the Tenderer is unable to obtain such documents - a statement by the Tenderer.

2) Technical potential:

The Tenderer will meet the condition if can demonstrate that will have the necessary technical potential to perform the contract, including at least one (1) vessel prepared to safely perform the subject service, equipped with survey systems required for proper implementation of the full range of services specified in the Scope of Work. In order to confirm that the above condition is met, the Ordering party requires the submission of a List of equippment (Appendix No. 3 to the tender inquiry) containing the list and specification of equipment to be used by the Tenderer in order to perform the subject matter of the contract.

- 3) Personnel participating in the contract performance:
 - The Tenderer will meet the condition if he demonstrates that for the execution of the contract will have at its disposal persons with education and professional experience necessary for the execution of the subject matter of the contract including, at least:
 - a) project manager one (1) person, having a university degree in the field of marine geosciences and at least five (5) years of professional experience in deep-sea exploration using remote sensing methods (geophysical, acoustic and physico-chemical), and interpretation of the obtained data, including those conducted onboard vessels;
 - b) specialist for hydrographic and geophysical surveys four (4) persons with a degree in hydrography, geophysics, marine physics, oceanography or geology with at least three (3) years of professional

- experience in the conducting of seabed measurements by remote methods, data processing and elaboration of results;
- c) specialist for measurements of the physico-chemical parameters of the water column two (2) persons, with a higher education in the field of marine physics or oceanography and a minimum of three (3) years of professional experience in conducting measurements, processing and elaboration of the physico-chemical water column data.

In order to confirm that the above condition is met, the Ordering Party requires the submission of a list of persons (Annex 4 to the request for quotation) directed by the Tenderer to perform the contract, together with information on their experience and education necessary to perform the contract in question, as well as the scope of their planned duties.

Attention: One person can perform only one function in the team, the Ordering Party does not allow the same person to be indicated for more than one function.

Each of the listed persons must be physically present on board during mobilization and cruise and must be fluent in English.

Tender Evaluation Criteria

When selecting the most advantageous offer, the Ordering Party will be guided by the following criteria and their importance:

1) Method of calculating the point value in the criterion of Price (P):

The maximum score for this criterion is 85 points.

2) Method of calculating the point value in the criterion of Quality (Q):

An offer within the Quality criterion may receive the following number of points for the offered quality of measurement data if the spatial resolution of bathymetric measurement data of MBES obtained at the reference depth of 3,000 m, as declared by the Tenderer, is within the following ranges:

The maximum number of points for this criterion is 15 points.

The selection of the most advantageous offer will be based on the number of points obtained on the basis based on the aforementioned tender evaluation criteria. The most advantageous offer will be an offer, which obtains the highest number of points - "H", based on the offer evaluation criteria calculated according to the formula:

H = P + Q

where:

H = total number of points obtained for each criterion,

P = number of points obtained in the Price criterion,

Q = number of points obtained in the Quality criterion.

- 7. Important contract provisions: (warranty, deadlines, terms of acceptance and payment, anticipated changes in the agreement and conditions of such changes): constitutes Annex 6 to the tender inquiry.
- 8. Offers on the form enclosed as Annex No. 2 to this tender inquiry should be submitted via the purchasing platform available at: https://platformazakupowa.pl/pn/pgi
- 9. The offer and any attachments should be affixed with a qualified electronic signature by an authorized person.
- 10. The tender shall be supplemented by:
 - a) formal documents of the Tenderer, such as information from a relevant register, such as a court register, or, if there is no such register, another equivalent document issued by a competent judicial or administrative authority of the country where the Tenderer has its registered office or place of residence, which shows the power or basis to represent the Tenderer;
 - b) if the Tenderer is represented by a representative, the power of attorney shall be attached to the tender and signed by a person/s authorized to represent the Tenderer. The content of the power of attorney has to clearly indicate the activities that the attorney is authorized to perform (scope of authorization);
 - c) initial plan of execution of the service together with the schedule of the proposed offshore survey, as well as information concerning organization of work and workflow, including the methods of ensuring quality of collected data and its control, as well as methods of recording and safe storage.
- 11. The deadline for submission of tenders is 11.02.2022 at 23:59 CET.
- 12. The tender validity period is 60 days from the tender submission deadline.
- 13. Procurement carried out by the Ordering Party via the purchasing platform takes place using the website https://platformazakupowa.pl/pn/pgi which means that tenders submitted otherwise than via the platform are not accepted. The Ordering Party shall inform Tenderers of the selection of the most advantageous tender, indicating the name of the Tenderer whose offer was selected. This message will be published on the purchasing platform in the "Announcements" section.
- 14. Communication between the Ordering Party and Tenderers, in particular the submission of declarations, requests, notices and the transmission of information, takes place via the Platform "Send a message to the Ordering Party" form, available on the Platform page for a given procedure. The date of submission (receipt) of declarations, requests, notifications and information shall be considered the date on which they are sent via the Platform by clicking the "Send message to the Ordering Party" button, after which a message will appear that the message has been sent to the Ordering Party.
- 15. The Ordering Party informs that detailed instructions for submitting, amending and withdrawing a tender can be found in the "Instructions for Bidders" tab on the website at: https://platformazakupowa.pl/strona/45-instrukcje

- 17. The elements of the tender that the Tenderer intends to reserve as the secrecy of the entity within the meaning of Article 11 (2) of the Act of 16 April 1993 on unfair competition shall be marked and described as "secrecy of the entity". In this case, appropriate justification shall be submitted with the tender.
- 18. Other Information:
 - 1) The Ordering Party reserves the right to amend this Tender Inquiry before the deadline for submission of tenders.
 - 2) Tenders in the procedure are public.
 - 3) The Tenderers may modify or withdraw their tender by notifying the Ordering party before the tender submission deadline.
 - 4) A tender and its appendices must be in English, legible, logical, in writing using a writing medium which cannot be removed without leaving traces.
 - 5) All prices shall be stated in Euros (EUR) to two decimal places and all payments shall be made in Euros, in accordance with applicable regulations.
 - 6) The Economic Operator may ask the Ordering Party to clarify the contents of the tender inquiry. The Ordering Party shall provide the Tenderer with the answers to their questions without disclosing the source of the question, and if the inquiry is available on the website, it shall be published on the Platform.
 - 7) The Ordering Party may demand explanations from the Tenderer regarding the contents of submitted tenders and supplementation of the requested documents and statements.

- 8) The Ordering Party reserves the right to correct in the Economic Operator's tender: obvious clerical and accounting errors as well as other errors which do not cause significant changes. In the case of calculation errors, the Ordering Party shall accept as correct the net unit prices and recalculate the tender according to the method indicated in Appendix No. 2 to the request for quotation (Tender Form).
- 9) Tenders submitted under a condition, after the deadline and variant (alternative) tenders will be rejected.
- 10) The Ordering Party may request explanations if the price of a tender (or its significant components) seems abnormally low particularly in relation to the subject matter of the contract and raises doubts of the Ordering Party to the possibility of performing the subject matter of the contract in accordance with the requirements specified by the Ordering Party or resulting from separate regulations, including submission of evidence regarding price calculation.
- 11) If in a procedure the only criterion for evaluation of tenders is the price and it is impossible to select the winning tender due to the fact that tenders with the same price have been submitted, the Ordering Party shall have the right to call upon the Tenderer who submitted tenders to submit additional tenders within the established time limit. When submitting additional offer the Tenderer cannot offer less advantageous conditions than those offered in their tenders.
- 12) The Ordering Party reserves the right to score offers based on the criteria specified in the request for quotation first and then examine only the offer of the Economic Operator who received the highest number of points regarding the offer evaluation criteria. The Ordering Party may not examine the remaining tenders.
- 13) If the Economic Operator, whose tender was considered the most advantageous, evades entering into a public procurement contract, the Ordering Party may choose the most advantageous tender from among the remaining tenders.
- 14) The Ordering Party reserves the right not to award a contract which is the subject matter of this procedure without giving any reason and to cancel the procedure.
- 15) The Ordering Party reserves the right not to award a contract in the event of not receiving two valid bids. In such a situation, the Ordering Party reserves the right to repeat the procedure.
- 19. In accordance with Article 13(1) and (2) of Regulation (EU) 2016/679 of the European Parliament and of the Council (EU) of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (Official Journal of the EU L 119 of 04.05.2016, p. 1), hereinafter "RODO", the Ordering Party informs that:
